This voluntary recall is due to potential *Salmonella* contamination, discovered through third party lab testing initiated by our manufacturer. While it has not yet received a classification, it will likely be

classified as a Class 1 Recall according to FDA guidelines. To date, no serious public health incidents have been reported.
