Lundberg Family Farms has established an Integrated Pest Management Program to help ensure the quality and safety of our products. As our product is organic, we do not use conventional chemical practices for control or prevention. Our Integrated Pest Management Program consists of the following:

- Sanitation
- Monitoring devices, pheromone traps, mechanical traps and software to aid in trends
- Regular inspections of paddy rice, bin/silos and finished goods
- Atmospheric treatment with CO2 and heat treatments are utilized when necessary
- Corrective actions are discussed with our team to ensure ongoing success of our programs

Our Quality Team, in conjunction with our Integrated Pest Management Team, investigated samples of retains, existing stock, intermediates and finished products, confirming that this was an isolated incident that should not affect all bags within these lot codes.

However, to avoid any unpleasant customer experiences, we recommend you check on hand inventory for these lot codes and destroy for credit. If this product is no longer within your control and has been shipped to secondary customers, we suggest you advise them to inspect product on the shelf for any signs of pest activity. If present, direct them to destroy the product for credit as well. If you provide us with evidence of credit provided, we will reimburse you for that credit.
