Amy's Kitchen has initiated a voluntary Class II recall for a single lot (30K0823) of the Gluten Free Bean and Cheese Burrito (single serving) due to the potential presence of foreign material (visible white plastic). The company is recalling the lot out of an abundance of caution to ensure the safety of consumers. There have been no reports of injury associated with this issue. The Food and Drug Administration (FDA) has been notified of this voluntary recall. No other Amy's Kitchen products or lots are involved.
