Situation

This **voluntary withdrawal** is being conducted due to the potential presence of mold in a limited number of Drumroll Mini Muffin packages due to the product being out of temperature spec at the manufacturer level. Based on the nature of the issue, this withdrawal is anticipated to be classified as a Market withdrawal. The withdrawal is limited to specific Mini Muffin lots and Best By Dates and does not extend to any other Drumroll products.

Next Steps

- Immediately inspect your inventory and destroy products with the affected UPC & BBD that reside in your distribution centers, stores, and/or warehouses. Please confirm that any current inventory of these UPCs and Best by Date is quarantined and henceforth destroyed.
- We ask all open orders that contain these items (8-50017-60446-9 and 8-50017-60449-0) be cancelled or quantities revised to 0 until the issue at hand is resolved.
- To ensure consistency and quality, we are pausing the Mini Muffin product line until the investigation is complete and reintroduction timing is confirmed.
- We will provide weekly updates to ensure transparency and timely communication as new information becomes available.
