At Yogi, we value the consumer experience and have high standards related to our Organic program. As part of a recent annual audit, a raw material sample of Echinacea tested above the acceptable limit for multiple pesticides. While there is no health or safety risk, the ingredient's quality is not in alignment with our product standards, packaging statements, or our company values.

In response, we have initiated a Class 3 Recall protocol to remove all products with this ingredient that remain in circulation. All customers have been notified in accordance with FDA standards with a request to remove and destroy all products containing this ingredient. Our Sales and Customer Service Teams are standing by to help process refunds and we are diligently working to replace the product in a timely manner. Further, we are no longer sourcing any product from the supplier who provided this ingredient. Any potential interruption in product availability will be communicated in due course.

Yogi's Sourcing and Quality Teams are working in lockstep to ensure we continue to meet the high expectations we hold for our products.
