## RECALL OF RAO'S SLOW SIMMERED SOUP LABELED AS CHICKEN & GNOCCHI BUT CONTAINING VEGETABLE MINESTRONE

Dear United Natural Foods,

Sovos Brands Intermediate, Inc. ("Sovos") is voluntarily recalling a limited number of 16-ounce jars of Rao's Made for Home Slow Simmered Soup, Chicken & Gnocchi because they may contain vegetable minestrone, which contains egg not declared on the Chicken & Gnocchi label. The affected soup is labeled as Chicken & Gnocchi, but will contain vegetable minestrone, which is dark red.

The lot information for the affected lot of soup is **Best By NOV 15 2024 EST 251 Code Date 2320 MDV 046030Z009**, **UPC 747479400015**. **Only Code Date 2320 MDV 046030Z009 is potentially impacted.** Please immediately check your inventory of soup from the affected lot and segregate and hold any jars that are labeled with the Chicken & Gnocchi soup label but which contain vegetable minestrone.



The Chicken & Gnocchi soup label does not declare the presence of egg within the vegetable minestrone that may be in the jar. People who have an allergy or severe sensitivity to egg run the risk of serious or life-threatening allergic reaction if they consume vegetable minestrone soup believing that it is Chicken & Gnocchi soup. To date, Sovos Brands has not received any complaints of injury or illness or any consumer inquiries regarding the affected soup.

#### The affected soup was distributed to you between December 8, 2022 and January 20, 2023.

If you have received any returned jars of the affected Chicken & Gnocchi soup from consumers, please issue a refund for the returned product, immediately quarantine and hold such units, and
