After receiving complaints in the market from customers about mold in the above two products, we've discovered that a 3<sup>rd</sup> party warehouse didn't follow our protocol to destroy a large part of this lot during a specific timeframe, which we knew was contaminated. As this product has shipped to customers throughout the country it's impossible to determine exactly where contaminated product has landed.

We kindly ask all customers having received this product to withdraw it from their warehouse, shelves and inventory and destroy.
